Dear Friends

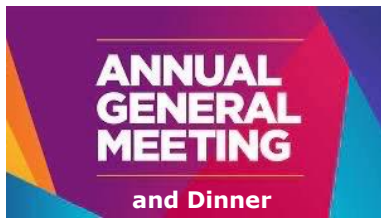
